Re: Coronavirus/COVID-19 Pandemic Precautions & Program Decisions

Sunbeam Community & Developmental Services ensures that safeguarding the health and wellbeing of our clients, their families, our staff and volunteers continues to be our priority. We remain committed to ensuring that our Coronavirus / COVID-19 pandemic safeguards, precautions, protocols and communications align* with the most current guidance and direction available from local, provincial and national health authorities as it pertains to Developmental Services organizations and Essential Services providers.

* Based on assessed level of risk to the safety and health of persons served and/or staff, Sunbeam reserves the right to introduce heightened pandemic precautions (beyond the guidelines provided by MCCSS, Public Health, and other government and health authorities), and/or to temporarily pause or revert to an earlier stage in provincial re-opening guidelines, and to apply either approach across one or more operating divisions, or to apply in a site specific manner.

RECENT UPDATES FROM GOVERNMENT & HEALTH AUTHORITIES

Ontario Declares Second Provincial Emergency to Address COVID-19 Crisis and Save Lives
Province Issues Stay-at-Home Order and Introduces Enhanced Enforcement Measures to Reduce Mobility
Excerpts from the Provincial Announcement from the Office of the Premier
January 12th, 2021

In response to a doubling in COVID-19 cases over the past two weeks, the real and looming threat of the collapse of the province's hospital system and alarming risks posed to long-term care homes as a result of high COVID-19 transmission rates, the Ontario government, in consultation with the Chief Medical Officer of Health and other health experts, is immediately declaring a second provincial emergency under s 7.0.1 (1) of the *Emergency Management and Civil Protection Act* (EMPCA).

"The latest modelling data shows that Ontario is in a crisis and, with the current trends, our hospital ICUs will be overwhelmed in a few short weeks with unthinkable consequences," said Premier Ford. "That's why we are taking urgent and decisive action, which includes declaring a provincial emergency and imposing a stay-at-home-order. We need people to only go out only for essential trips to pick up groceries or go to medical appointments. By doing the right thing and staying home, you can stay safe and save lives."

Effective Thursday, January 14, 2021at 12:01 a.m., the government is issuing a **stay-at-home order** requiring everyone to remain at home with exceptions for essential purposes, such as going to the grocery store or pharmacy, accessing health care services, for exercise or for essential work. This order and other new and existing public health restrictions are aimed at limiting people's mobility and reducing the number of daily contacts with those outside an immediate household. In addition to limiting outings to essential trips, all businesses must ensure that any employee who can work from home, does work from home.

Additional Public Health Restrictions

In response to the alarming and exceptional circumstances at hand, and to further interrupt the deadly trend of transmission in Ontario communities, hospitals, and long-term care homes, the government will enact the following additional public health measures:

- Outdoor organized public gatherings and social gatherings are further restricted to a limit of five people with limited exceptions. This is consistent with the rules during the lockdown during the first wave of COVID-19 in spring 2020 and will allow individuals and families to enjoy time outdoors safely.
- Individuals are required to wear a mask or face covering in the indoor areas of businesses or organizations that
 are open. Wearing a mask or face covering is now recommended outdoors when you can't physically distance
 more than two metres.
- All non-essential retail stores, including hardware stores, alcohol retailers, and those offering curbside pickup or delivery, must open no earlier than 7 a.m. and close no later than 8 p.m. The restricted hours of operation do not apply to stores that primarily sell food, pharmacies, gas stations, convenience stores, and restaurants for takeout or delivery.
- Non-essential construction is further restricted, including below-grade construction, exempting survey.

These measures will come into effect between Tuesday January 12, 2021 and Thursday, January 14, 2021, including the provincial declaration of emergency under the EMCPA, orders under that Act, and amendments to regulations under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020.

Background: On November 13th, the Ontario government announced its "Adjustments to COVID-19 Response Framework" which utilizes the following pandemic response categories:











On December 21st, the Ontario Government announced an Ontario-wide LOCKDOWN due to the COVID-19 pandemic:

"The lockdown will begin at 12:01 a.m. on Dec. 26 and remain in place until at least Jan. 23, 2021 in the 27 public health units that comprise southern Ontario. In the seven public health units in Ontario's north, where daily case numbers have been significantly lower, the lockdown is set to expire on Jan. 9, 2021." All 5 geographic regions and counties served by Sunbeam fall into the **LOCKDOWN** period of December 26, 2020 to at least January 23, 2021. In summary, <u>effective 12:01 a.m. on December 26th</u>:

- Waterloo Region changes from RED (Control) to LOCKDOWN to at least January 23, 2021
- Peel Region remains in LOCKDOWN to at least January 23, 2021
- Halton Region changes from RED (Control) to LOCKDOWN to at least January 23, 2021
- Wellington County changes from RED (Control) to LOCKDOWN to at least January 23, 2021
- Dufferin County changes from RED (Control) to LOCKDOWN to at least January 23, 2021



Direction to MCCSS-funded service providers with congregate care settings in all regions (excluding youth justice):

- <u>Service providers must adhere to this Interim Direction</u> for pandemic precautions, which will remain in effect for the duration of the <u>LOCKDOWN</u> period.
- To be clear, while this Interim Direction is in effect previously issued pandemic precaution direction from MCCSS is suspended.

MCCSS Emergency Orders Extended

Extension of Regulations under the Reopening Ontario (A flexible Response to COVID-19) Act, 2020 December 14th, 2020

Ontario Regulations 121/20, 145/20, and 177/20 under the Reopening Ontario (A flexible Response to Covid-19) Act, 2020 have been extended until January 20, 2021. These orders impact adult developmental services, intervenor services, anti-human trafficking and violence against women sectors and are an important tool to help protect the health and safety of residents and agency staff.

Approval of Pfizer COVID-19 Vaccine

December 9th, 2020

As announced on Dec 9, 2020, Health Canada has approved the Pfizer COVID-19 Vaccine.

Federally it has been decided that the vaccine will be allocated on a per capita basis provincially, and provinces will determine their prioritization and allocation methodology. Ontario has thus far identified key populations to receive the vaccine first, including long-term care and retirement home residents and the staff who provide care to these groups.

Enhanced Source Protection Measures and Active Screening

Ministry of Children, Community and Social Services November 30th, 2020

With the support and advice of the Office of the Chief Medical Officer of Health, MCCSS is requiring additional source control measures for staff and visitors of MCCSS funded congregate living settings. In addition, the Ministry is expanding the active screening requirements for anyone entering a congregate living site.

The following enhanced source control measures must be implemented within 5 business days:

• All staff must wear both a surgical/procedure mask AND face shield while working within the congregate care setting.

All indoor visitors, regardless of designation (essential, non-essential and designated) must wear a surgical/procedure
mask. Where a physical distance of 2 meters or 6 feet cannot be maintained, visitors are advised to a wear a
surgical/procedure mask AND face shield. Outdoor visitors are only required to use a face covering (e.g., nonmedical/cloth mask).

In addition to existing screening requirements, <u>agency screening must be enhanced</u> where specified additional questions must be asked to all individuals <u>seeking to enter the setting.</u>

Agency screening must also be enhanced for staff by way of specified additional questions.

Please remember that interacting with colleagues outside of work without face coverings and social distancing raises the risks of COVID-19 transmission.

ANNOUNCEMENT: COVID-19 VACCINATIONS

Updated Jan 12, 2021:

Sunbeam Community & Developmental Services has been advocating for the developmental services sector to be included for priority access to COVID-19 vaccinations. Working closely with government and health authorities, locally and provincially, our voice is being heard for both front-line staff vaccinations and vaccinations for the vulnerable persons we serve.

As at January 12th, 2021 Sunbeam has been offered a total of 125 confirmed COVID-19 vaccinations (each vaccination consisting of two appointments - 1st dose and 2nd dose) for staff, with the first dose being administered by January 11th.

The vaccination appointments are being offered and assigned to staff in priority sequence, based on safety and risk factors related to the care and support of our persons served in congregate living settings. More staff vaccination offers will be forthcoming from the local health system, but the timing of additional staff vaccination offers is not known at this time.

Per overall the overall provincial COVID-19 vaccination framework for vulnerable sectors, we anticipate that staff vaccinations will be followed by vaccinations for persons served in congregate living settings.

SPECIAL NOTES REGARDING PANDEMIC PROTOCOLS IN OUR RESIDENTIAL PROGRAMS (GROUP HOMES)

- Admissions to, and transfers between our residential care homes are paused, with consideration given to special or urgent situations guided by government and health authority guidance and direction.
- Single-site assignments are currently standard practice for Sunbeam's from line staff in Community Living Services. Where exceptions may be needed based on operational needs, internal pandemic protocols exist to ensure safe practices.
- Definitions of Essential Visitors, Designated Visitors and Non-Essential / Friendly Visitors are provided on the "COVID-19 INFO" page of Sunbeam's website.
- Service providers must adhere to the MCCSS Interim Direction for pandemic precautions, which will remain in effect for the duration of the **LOCKDOWN** period.
- To be clear, while this Interim Direction is in effect previously issued pandemic precaution direction from MCCSS is suspended.
- For information about short-stay absences, outings, and essential overnight absences, please refer to the aforementioned resources.

RE-OPENING PLAN

*** Sunbeam's Re-Opening Plan is temporarily suspended, due to the announced provincial LOCKDOWN period of Dec 26-2020 to at least Jan 23-2021 ***

Information regarding Sunbeam's Re-Opening Plan is provided here for reference.

On May 14th, 2020 the Ontario Government announced how the province will start to reopen its economy and phase out some emergency restrictions that were imposed to combat COVID-19. Ontario will begin to phase-out its semi-lockdown starting on May 19th. The province developed a framework to guide its approach, outlining the principles to be used to responsibly "return to normalcy."

As Sunbeam develops its re-opening plan, we are guided by the province's framework, which is guided by the advice of the Chief Medical Officer of Health and public health officials.

With an abundance of caution, Sunbeam's graduated re-opening plan has been developed with SAFETY as our top priority, recognizing the need for flexibility and the ability to adapt to changing circumstances throughout. Planning and implementation timelines will be determined based on orders, directives and advice from government and health authorities combined with local pandemic environmental considerations.
